Instructions for Online Submission

It's easy to submit evidence of insurability (EOI) online. Follow these simple steps:

- 1. Log in to MyLincolnPortal.com First time user? Register using company code **Brynmawr**
- 2. Click Complete Evidence of Insurability / Statement of Health
- 3. Answer the questions asked
- 4. Electronically sign and submit
- 5. Save your confirmation report

Submitting EOI is an important step in applying for the right amount of life insurance to protect the future of your loved ones. It is a health questionnaire that helps us determine whether you and other dependent applicants qualify for new coverage or an increase in coverage. We make it easy to submit EOI online through MyLincolnPortal[®]:

- General applicant information such as birthday, height, and weight
- Qualifying questions including if you or other applicants have been diagnosed with a disease or are prescribed medications for a condition
- Medical questions if you or other applicants have a condition, we may need to know a little more about it such as the name, diagnosis date, and treatments





Save time! Collect the following information about each applicant before you get started:

- Date and place of birth
- Height and weight
- Social Security Number
- Medical history (types and dates of conditions)
- Medications



- 4. Review your responses, then electronically sign and submit your application
- 5. Save your confirmation report

In straightforward cases, you may be auto-approved for coverage. If not, we'll review your application and contact you if any additional information is required. In all cases we'll notify you of your application outcome.
